NLAC USBC BVL QUALIFYING RULES

QUALIFIER RULES:

1. This qualifier will be a mail-o-graphic tournament certified by the USBC.
2. All entrants must be in good standing with the USBC and must hold a valid USBC membership card.
3. **Format:** Scratch competition within divisions. Bowlers will submit their league scores within the window of November 12-18, 2017. These scores along with BVL paid entrants scores from the Senior Singles tournament will be tabulated together in their appropriate BVL division. **First place finishers in each division will receive a free entry into the California USBC Helen Duval Veterans Tournament representing the NLAC USBC.** No ties for first place. In the event of a tie for first place, the series with highest 3rd game will determine who will move on to the State Finals. If the 3rd game is also a tie, the highest 2nd game will determine the qualifier and so forth.
4. **ENTERING AVERAGES:**
 - a. Use the highest USBC certified average from the 2016-17 season (Winter and Summer) minimum of 21 games or more; if none,
 - b. Highest USBC current certified league average as of tournament date; USBC Rules 319C, 319D and 319E shall not apply.
Bowlers are responsible for verifying their own average. If the submitted average is incorrect, the score will be disqualified.
5. No refunds (USBC rule #316) and no substitutes permitted. However, replacements may be used based on the order of finish per division.
6. Tournament management shall be the authority to interpret USBC and tournament rules, policies and procedures in deciding disputes. An appeal or protest of a decision involving eligibility or playing rules must be filed in writing with the tournament director and the USBC before tournament prizes are paid. The decision of USBC is final and binding on all involved parties. Any violation of tournament rules is cause for disqualification, loss of entry fee, forfeit of all prize monies and possible suspension from USBC membership. USBC Rule #329 (appeal or protest) will apply.
